

NOTICE OF RACE
National MOTH INTERNATIONAL 2018
From Friday 20th to Sunday 22nd April
Organizing Authority : Association Sportive et Nautique de Quiberon

1. RULES

The regatta will be governed by:

- Rules as defined in the rules of sailing race 2017-2020 (RRs)
- Regulations and prescriptions by the FFVoile

In the event of a conflict in the translation, the French text will prevail.

2. ADVERTISING

Pursuant to regulation 20 of World Sailing (advertising Code), as amended by the FFVoile advertising regulations, vessels [may/must] be required to carry the advertisement chosen and provided by the organising authority.

3. ELIGIBILITY AND ENTRY

The regatta is open to the foiling International Moth

The competitors (each member of the crew) residing in France must submit at the time of their registration:

- their Club FFVoile valid "competition" licence attesting prior presentation of a medical certificate of non-contraindication to the practice of sailing in competition.
- or their license ClubFFVoile with the mention "accession" or "practice" accompanied by a medical certificate of non-contraindication to the practice of sailing in competition dating from less than one year
- Parental permission for minors
- If necessary, the authorization to carry advertising.

Foreign competitors who do not have a FFVoile licence must submit at the time of registration:

- A proof of their membership of a national authority member of ISAF,
- The certificate of measurement or conformity,
- A valid proof of insurance in civil liability with a minimum coverage of EUR 1, 5 million,
- A medical certificate of non-contraindication to the practice of sailing in competition dating back less than one year (written in French or English) as well as a parental authorization for underaged competitors.

4. REGISTRATION FEE

For registration and payment until April 7th, reduced rates :

- National Moth : 95 euros

The amount of the registration fee after April 7th :

- National Moth : 120 euros

This price includes:

- The tee shirt of the event
- The lycra of the foils day of the ENVS - Bay of Quiberon
- The evening of the crews at the ASNQuiberon of Saturday 21 May.
- Storage of rigged material on the premises of the ENVS

Evening rate Attendant: €12 adult, €7/child check on the registration form

Any competitor wishing to participate in the National MOTH must send a request for registration accompanied by the Payment by bank cheque payable to the order of A.S.N. Quiberon.

Cancellation of commitments :

Cancellations of registration, package declarations and claims for reimbursement must be expressed by mail in order to avoid any dispute.

The reimbursement of the registration fee will be carried out according to the following scheme:

- Any cancellation before April 7th will be fully reimbursed
- Any cancellation between April 7th and April 20 will be reimbursed at 50%
- After April 20th, no refund application will be accepted.

Sunday April 22 nd	9:30: ENVSN Briefing Sailors 10:00:1st warning signal; one to several races to follow No warning signal will be given after 15:00 After the races: awards ceremony and closing drinks.ENVSN

6. RUNNING INSTRUCTIONS

The race instructions of "National MOTH INTERNATIONAL" will be available at the registration confirmation on Friday, April 20th

8. CLASSIFICATIONS & RATINGS

8.1 The following classifications will be established :

- IFM (International Foiling Moth)

8.2 - The FFVoile rating system will be used to establish the rankings of the National MOTH INTERNATIONAL 2018

9. DECISION TO RUN

The decision of a competitor to participate in a race or to stay in the race is his/her sole responsibility. Consequently, by agreeing to participate in the race or to stay in the race, the competitor discharges the organising authority from any liability in case of damage (material and/or bodily).

10. RIGHT TO USE NAME AND APPEARANCE:

By participating in this event, the competitor automatically authorizes the organising authority and the sponsors of the event to be used and to show either moving or static photos, films or television recordings, and other reproductions of himself/herself during the period of the competition entitled "National MOTH INTERNATIONAL 2018", to which the rider participates and to use without compensation his image on all materials related to the said event.
